## **OLD Business**

- Trail Landing Sign (Colin)
  - Will and Consider Master's Touch
  - $\circ$  Size  $\rightarrow$  not too big. Around 2'x3' or so
  - Timeline- before road opens (early May at latest)
- Winter grooming equipment purchase (Tony)
  - Background- historically MAMBA has tried lots of different ways to groom, all with limited success
  - Community Member has been grooming with a Snow Dog (google it for machine details). This citizen has used the machine solely for mountain grooming, and not personal use.
    - Consider the purchase of community member's machine, and to back pay for rental.
  - Motion by Matson to purchase Snow Dog from community member, and to pay for past use, up to \$3500. Second Pollard. Motion Passes. The Treasure (Matson) will execute the transaction.
  - Motion by Matson to upgrade Snow Dog (slider suspension vs rollers) up to \$350. Second Priebe. Greater than \$350 will be discussed via email etc.

- West Twin: Land Owner has been working with Priebe to build a trial up to West Twin (Long has been CC'ed on these communications). Priebe submitted plans to her, which she has circulated to her adjacent landowners. She is working on landowner approval; MAMBA will establish the trail. Timeline: about 2 years of work. Length about 2.5+ miles. Around 7% grade.
  - Route from West Twin to Headwaters is the goal
  - Goal of trail is to remove moto use. Wilddog will go away :-(
